11/05/2018 **Members Directory / Privacy Settings** -- Although many members have logged-in and updated their Privacy Settings for the Members Directory, it appears too many have inadvertently set themselves as "ex-directory". Other members needing to arrange league and tournament matches are complaining they can't make contact to arrange their matches. As such, any members who are completely ex-directory are now prompted to show some contact details upon each login, as per following screen shot.
